A. Relating to E-Voting:

- The remote E-Voting period remained open from 9.00 a.m. on Monday, 8th November, 2021 to 5.00 p.m. on Thursday, 11th November, 2021.
- 2. The Annual Report containing the Notice was sent by electronic mode to those members whose E-mail id's were registered with the Depository Participants and for other members, hard copy of Annual Report containing the Notice was sent by Registered Post.
- 3. The e-voting event was unblocked on November 12, 2021 around 10.52 a.m.in presence of two witnesses, namely Mr. Hiren Gor residing at A 13, Shive Om Apartment, S.V Road, Dahisar (e), Mumbai 400068. and Mr. Hemal R. B. Relating to voting by Poll:

- 1. After the time fixed for closing of the poll by the Chairman, the ballot box were opened in my presence and poll papers were diligently scrutinized.
